STARK COUNTY GOVERNMENT BUILDINGS OPENING JUNE 10th

Dickinson, ND – By order of the Stark County Board of Commissioners, all County buildings including the courthouse, county shops, fair buildings, Law Enforcement Center, and NDSU Extension office will open June 10th. Patrons will be screened prior to entry. It is at the discretion of each individual department to determine if a patron is to wear a mask upon entry into their facility/area.

The safety of Stark County citizens and our employees remain our top priority and precautionary measures within our facilities are being taken. Our maintenance department is implementing extra sanitation measures during the day to ensure heavily used items and high traffic areas are disinfected. Maintenance employees will disinfect all common area surfaces twice daily. Employees are also encouraged to frequently clean and disinfect touched objects and surfaces, two to three times a day. Social distancing practices are also encouraged to be followed in accordance with CDC guidelines.
